Your electives should be chosen from the graduate courses offered by the departments in the Ansell School of Business (e.g., Management, Marketing).

Please check the January and May intersessions for elective MBA courses. Some electives are offered only in the summer sessions.

MHA & MSJA courses. Please note that courses in the Master of Healthcare Administration (MHA) and the Master of Science in Justice Administration (MSJA) **may** be available as MBA electives. Please check with the MBA Coordinator and the MHA or MSJA Coordinator before registering for MHA or MSJA courses. Please see the Graduate Catalog for details.

Non-Ancell courses. Some courses offered by departments outside the Ansell School of Business (e.g., communications) **may** be taken as MBA electives. The course must be demonstrably relevant to your MBA program, your job, or your career needs. Please receive approval for these courses in advance from the MBA Coordinator.
